

**CRUNCH SURVEY SWEEPSTAKES

Monthly Entry Period #10: Between 12:00 AM EST on March 1, 2026 and 11:59 PM EDT on March 31, 2026;

Monthly Entry Period #11: Between 12:00 am EDT on April 1, 2026 and 11:59 PM EDT on April 30, 2026; and

Monthly Entry Period #12: Between 12:00 AM EST on May 1, 2026 and 11:59 PM EDT on May 31, 2026

Monthly Entry Period #11: Entries must be postmarked by April 30, 2026 and received by May 7, 2026;
and
Monthly Entry Period #12: Entries must be postmarked by June 1, 2026 and received by June 8, 2026.

The answers to the Survey questions will not have any bearing on being selected as a Prize Winner.
